All of the members of the Board were present in person. Mr. Zachary Agee – Chair, Ms. Elizabeth Bowles – Vice Chair, Ms. Katherin Elam – Secretary and Dana Oliver, Director of Elections.

The purpose of the meeting is to canvass the results of the 2024 Presidential dual primary elections. Provisional ballots were presented first for review, this included same day registrations, all ten were cast.
